Remarks	Titanium dioxide (13463-67-7) In lifetime inhalation studies of rats, airborne respirable-size titanium dioxide particles have shown to cause an increase in lung tumors at concentrations associated with substantial particle lung burdens and consequential pulmonary overload and inflammation. The potential for these adverse health ef- fects appears to be closely related to the particle size and the amount of the exposed surface area that comes into contact with the lung. However, tests with other laboratory animals such as mice and hamsters, indicate that rats are significantly more susceptible to the pulmonary overload and inflammation that causes lung cancer. Epidemiological studies do not sug- gest an increased risk of cancer in humans from occupational exposure to titanium dioxide. Titanium dioxide has been char- acterized by IARC as possibly carcinogenic to humans (Group 2B) through inhalation (not ingestion). It has not been charac- terized as a potential carcinogen by either NTP or OSHA.



<u>IRRITANCY OF PRODUCT</u>: This product may mildly irritate contaminated tissue, especially if contact is prolonged. Eye irritation may be more pronounced.

<u>SENSITIZATION TO THE PRODUCT</u>: This product contains diisocyanate compounds, which are known human skin and respiratory sensitizers. Exposure can cause allergic reactions. Cross-sensitization between different isocyanates may occur.

Respiratory Sensitization: Initial symptoms of respiratory reactions may appear to be a cold or mild hay fever. However, severe asthmatic symptoms can develop and include wheezing, chest tightness, shortness of breath, difficulty breathing and/or coughing. Fever, chills, general feelings of discomfort, headache, and fatigue can also occur. Symptoms may occur immediately upon exposure (within an hour), several hours after exposure or both, and/or at night. Typically, the asthma improves with removal from exposure (e.g. weekends or vacations) and returns, in some cases, in the form of an "acute attack", on renewed exposure. Sensitized people who continue to work with diisocyanates may develop symptoms sooner after each exposure. The number and severity of symptoms may increase. Death has occurred in sensitized individuals accidently exposed to relatively low concentrations of diisocyanates. Following removal from exposure, some sensitized workers may continue to show a slow decline in lung function and have persistent respiratory problems such as asthmatic symptoms, chronic bronchitis and hypersensitivity for months or years. Exposure to isocyanates is likely to aggravate existing respiratory disease, such as chronic bronchitis, and emphysema.

Skin Sensitization: Repeated skin contact with diisocyanates has caused skin sensitization in humans, although the condition is not common. Once a person is sensitized, contact with even a small amount can cause outbreaks of dermatitis with symptoms such as redness, rash, itching and swelling.
